**Application Fee**

A one-time, non-refundable application fee of \$50 (per child) is required to submit an application to Monarch Christian Montessori.

**Enrollment Fee**

First time enrollment fee: \$250 (non-refundable)  
Re-enrollment fee: \$150 (Non-refundable)

**Material Fee**

An annual fee to cover materials throughout the year.

- Kindergarten: \$400
- Pre-Primary/Primary: \$200

**Summer Activity Fee**

An annual, summer session fee to cover the special activities.

- 5D: \$250 / 3D: \$200 / 2D: \$160

**Wait-List Fee**

If applicable, a wait-list fee of \$150 will apply towards the registration fee, when a space opens up.

**Tuition Deposit**

A one-month's tuition deposit is required and due at the time of enrollment. This will apply to the last month's tuition of the child's contract year. The one-month's tuition deposit will **NOT** be refunded if the child fails to complete the full school session.

**Before and After School Sessions**

The hourly rate will apply to a whole hour or any part thereof.

**FACTS**

- Monthly tuition payments are made to FACTS Tuition Management via automatic bank payments on the fifth (5<sup>th</sup>) of each month.
- FACTS has a non-refundable, annual enrollment fee of \$45 per family.

\*\*\* All monthly tuition payments are equal, regardless of holidays, student absences, teachers' in-service days, or school closures due to inclement weather, natural disaster, or an "Act of God," which prevents school operations.

\*\*\* **A 2 year-old tuition rate will be applied to the non-toilet trained child at any age.**

**Sibling Discount**

- 2<sup>nd</sup> child: 5% discount (applied to the lesser tuition amount)
- 3<sup>rd</sup> child: 10% discount

**Additional Hours**

- Authorized non-contract hours (before closing): \$15/hour with 24-hour advanced notice.
- Unauthorized non-contract hours (before closing): \$20/hour for any unauthorized late pick-up.

**Late Pick-Up Fees**

After 6:00 P.M., the late pick-up fee is \$1/minute for the first 10 minutes, \$2/minute for the next 10 minutes, and \$3/minute thereafter, until the child is picked up.

**Program/Schedule Changes**

A 30-day's written notice is required to change the child's program/schedule.

- 1<sup>st</sup> change: free of charge      2<sup>nd</sup> change: \$50
- 3<sup>rd</sup> change: \$75      Every change thereafter: \$90

**Withdrawal**

A 30-day's written notice must be submitted on or prior to the first day of the month, during which the child will cease to attend.

- During the two-week trial period, the contract may be terminated without any further obligation/explanation on either the school or parents' part. The tuition is prorated for the time the child is actually in attendance. The deposit is non-refundable, unless the school dismissed the child.
- The school reserves the right to dismiss new or continued enrollment for a child, if at any time, for any reason not prohibited by law, in the sole judgment of Monarch Christian Montessori, the school feels that it cannot meet the needs of a child or family.
